

## TAX CREDIT FOR WINDOWS AND DOORS

## Official Manufacturer's Certificate Window Mart

## **Equipment Tax Credits for Primary Residences**

\*\*Please note: The current tax credits for Residential Energy Efficiency (<u>Equipment Tax Credits for Primary Residences</u>) expired on December 31, 2021. As of January 5, 2022, there is no approved extension of these tax credits. Any extension/renewal of these credits is still pending approved legislation by Congress. We will update our website with updates when there is an approved bill. The tax credits for <u>Residential Renewable Energy Products</u> are still effective, as written on this site, through December 31, 2023.

JANUARY 2021: The Non-Business Energy Property Tax Credits were retroactively extended from 12/31/2017 through 12/31/2021

Tax Credit: 10% of cost up to \$500 or a specific amount from \$50-\$300.

Expires: December 31, 2021

**Details:** Must be placed in service in an existing home which is your <u>principal residence</u> by December 31, 2021. New construction and rentals **do not** apply.

Windows, doors, and skylights that earn the ENERGY STAR save energy, improve comfort and help protect the environment.

Tax Credit Amount: 10% of the cost, up to \$500, but windows are capped at \$200. (NOT INCLUDING INSTALLATION)

## Requirements

Must be ENERGY STAR certified.

You do not have to replace all the windows/doors/skylights in your home to qualify. And it doesn't need to be a replacement either - installing a new window where there wasn't one previously (like in an addition) qualifies. Tax credit does not include installation costs.

PREVIOUS tax credits include American Taxpayer Relief Act of 2012.

Window Mart certifies it produces certain windows and doors that qualify as Building Envelope Components and may be eligible for tax credits as defined in the American Taxpayer Relief Act of 2012. President Trump extended this Act and affects projects completed in 2012, 2013 and projects completed by December 31, 2017. This tax credit was extended to include 2015 (retroactive), 2016 and 2017 (announced 2/28/2018). This tax credit extended again to include 2018, 2019 (retroactive) and 2020 and announced in January 2020.
